REGULATORY SOLUTIONS, INC. SOLID WASTE PROCESSING FACILITY PERMIT No. 092622-2001

A. SPECIAL PERMIT CONDITIONS

- 1. The Permittee shall adhere to the final engineering plans/specifications and operational report, dated November 15, 2011, unless permit conditions state otherwise.
- 2. The Permittee shall not exceed the facility's processing capacity of twenty five thousand (25,000) tons of industrial solid waste per fiscal year (July 1 June 30). The Permittee shall make available to the Department, upon request, its records regarding the amount of waste being processed at the facility.
- 3. Pre-processed waste NOT classified as "non-conforming" that is stored in 55-gallon drums shall not exceed 144 drums. At any point that this limit is met this facility shall cease acceptance of drums with pre-processed waste.
- 4. Pre-processed waste classified as "non-conforming" that is stored in 55-gallon drums shall not exceed 5 drums. At any point that this limit is met this facility shall cease acceptance of drums with pre-processed waste.
- 5. Waste that is stored in roll-off containers (typically 20 yd³/ea. in size) shall not exceed 120 yd³ total or 84 tons total (whichever comes first). At any point that this limit is met this facility shall cease acceptance of waste.
- 6. Pre-processed and/or solidified waste that is stored within the solidification tank shall not exceed the capacity of the tank OR 34.1 tons (whichever comes first). At any point that this limit is met this facility shall cease acceptance of waste.
- 7. The Permittee shall contact the Department any time liquid will be removed from the sump, located behind the Facility that collects liquids for the secondary containment system.

B. GENERAL PERMIT CONDITIONS

- 1. The Permittee shall not allow any liquids to run off to the environment as a result of Regulatory Solutions' industrial solid waste processing operation.
- 2. Prior to the receipt of each shipment of metal containing absorbent agents (e.g. kiln dust), the Permittee shall obtain a current analysis on it. All analyses shall be kept onsite for Department review, upon request.
- 3. In order for the Permittee to use additional absorbent agents, other than those listed in permitted facility's permit application, written request shall be submitted to the Department, attention Manager of Solid Waste Permitting Section, BLWM, for review and approval.
